
RULES AND REGULATIONS

M/S.KARMINDER CHOHAN EDUCATIONAL SOCIETY

JEEDA, GONIANA – BAJA KHANA ROAD, DIST: BATHINDA-151201.

These rules and regulations shall be called rules of M/S.KARMINDER CHOHAN EDUCATIONAL SOCIETY, JEEDA, GONIANA – BAJA KHANA ROAD, DIST: BATHINDA

1. The membership of the Society will be open to all adult persons. The application for the membership shall be scrutinized by the President and Vice President. Member will not be eligible to join any other such type of Society or society without permission. The entrance fee will be Rs.100 and monthly subscription will be Rs.50/- i.e. Rs.600/- pa.
2. The member of the Society will constitute the General Body. It will be supreme authority. It will meet once in every financial year. The accounts of the Society shall be laid before it once a year. However additional extra ordinary meeting of the General Body can be called by President or Vice President.
3. The decision at the meeting shall be taken by the majority of votes.
4. The affairs of the Society shall be managed by Managing committee consisting of President, Vice President, Secretary and Cashier. The term of the First Managing Committee will be five years and member of Managing Committee shall be elected once in a period of five years in the annual general meeting thereafter.
5. The Managing committee shall meet as frequently as required. However twelve meeting must be held once in a year.
6. The decision of the Managing Committee shall also be taken by majority votes. However in case of tie, the president will have a casting vote.
7. The Managing committee will implement to the decision taken by General body. The Managing committee will have power to sanction any amount of expenditure. However the same will have to be approved by the General body at its meeting.
8. Bank account shall be opened in to name of Society and shall be operated President and Secretary or any other person authorized by the President.
9. The account of the Society shall be maintained regularly and closed on 31st of March every year. These shall be got audited from the Chartered Accountant before being laid before the General Body.
10. A change in rules can be made if it is approved by General Body at a meeting especially for this purpose.
11. Members of the First Governing Body of the Society will be the permanent members of the society & Non Resident Indians (NRI's) may be added as honorary members of the society.
12. A notice of 48 Hours shall be required to call a meeting of the General body and of 24 Hours to call the meeting of Managing Committee.
13. The President, Vice President, Secretary or any member of Managing Committee can be removed from its position before its tenure only if the General Body decides the same by 3/4 majority at a meeting specially called for this purpose. The member will not be eligible to continue as a member, if he remains absent for three consecutive meetings without any reason. However, who is being removed is given a chance to represent himself before the General Body.

AREA OF OPERATION


The area of the operation of the Society will be at Punjab.

The objects of the Society are established as under:-









- f) To arrange and organize various kinds of child welfare programmes etc.
- g) To purchase/acquire the land and/or building in the name of Society and make construction thereupon.
- h) To promote the dream of Late Sh. Karminder Singh Chohan to provide the quality education to kids of Rural Punjab.
- i) To do such other things/acts/activities which are necessary and which may be incidental or conducive to the attainment of any object of the Society.

For the achievements of the above mentioned aims and objects, the Society shall have the authority to accept grants, subsidies, donations (from within India or overseas) and gifts to receive loans from the Central Government, State Government, Local Authorities, bank or any body, or association whether incorporated or not or hypothecate movable and immovable properties, to establish centers and to incur expenditure to do whatever may be needed for the promotion of the aims and objects of the Society from time to time.



15. A member of General Body can be removed from the membership by the Managing Committee in accordance with the rules framed by General Body.


